### STREET PARKING BLOCKING DRIVEWAYS

Street parking is an often brought up complaint that the Board receives year after year. The streets are owned by the City of Middletown and are subject to their regulations on this subject, which parallels Metro Louisville's parking regulations. First, street parking is permissable so long as it does not impede access by Police, EMS, or the Fire Department. Should any of the three aforementioned departments be blocked or hindered access to a house on a street due to street parking, the owner of the offending vehicle(s) would be subject to towing, impoundment and subsequent fees. Special mention regarding garbage truck access is called for. Simply put, if a garbage truck is prevented access to all or part of any street due to steet parking blocking access, the garbage will not be picked up.

The Board realizes that from time to time, residents of the 100-200 block of Beckley Woods Drive may experience the temporary need to park on the street for a short time. Since this stretch of Beckley Woods Drive only provides one lane in each direction, care should be taken to park as close to the right hand curb as possible, with an eye towards limiting this situation to a short period. Indeed, we never wish to see a passing vehicle need to run one side of the vehicle up onto the median where the possibility of damaging the sprinkler system may occur. This almost always results in a costly repair to the irrigation system. Along these lines, please take care when exiting Beckley Woods at US 60 as to not drive up onto the medain. The past several years we have suffered damages to the irrigation system at this particular point, costing hundreds of dollars in repairs to the irrigation system, caused by vehicles that try to ease past the waiting car ahead at the traffic light.

Finally, when parking on the street, exercise consideration to your neighbor living across the street. Please remember that they need to enter and depart their homes via their driveway, and parking a vehicle directly across the street from a driveway can be an obstacle to safety.
