We continue to face some unique challenges. Our agency continues to seek creative ways to meet our mission, objectives, and serve our community in this difficult time.

We will be adding statistical data to our report for your review. In the Fire Service, we commonly use NFPA standards for service delivery performance measures. These are based upon studies, industry best practices, and are consensus based - through the work of technical committees. While we navigate the holidays and the change in seasons, we would like to offer additional resource information. This year has been fraught with many unknowns. We continue to be encouraged by vaccine news, and continuous updated research related to therapeutics and treatment of COVID-19. 

Is it time to replace your smoke alarms? Are the alarms in your home placed in recommended locations? The National Fire Protection Association - nfpa.org/smoke alarms details the following: "Make sure they are installed inside each bedroom, outside sleeping areas, and on every level in the home". Track your alarm life span—alarms with 10 year non-replaceable batteries have an expiration date and should be replaced accordingly.
