This Model Release (the "Agreement") is made and entered on _____ by
and between Aydin B. Photography (the "Photographer"), and The Model listed above (the "Model").

WHEREAS, the Photographer desires to photograph the Model and the Model desires to be photographed by
the Photographer for the purpose of building their respective portfolios and for non-commercial use;

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties
agree as follows:

1. Grant of Rights: The Model hereby grants to the Photographer the irrevocable, perpetual, non-exclusive, royalty-free right and license to use, reproduce, publish, display, exhibit, transmit, distribute, and create derivative works from the photographs taken of the Model during the photography session (the "Photographs"), in any and all media now known or hereafter devised, throughout the world, for the following purposes:
 - a. Portfolio Use: The Photographer may use the Photographs in their portfolio, website, social media, and other promotional materials to showcase their work.
 - b. Model's Use: The Model may use the Photographs in their portfolio, website, social media, and other promotional materials to showcase their work. The Model may share images on their social media platforms, provided that the images are not altered (other than reasonable cropping).
 - c. Non-Commercial Use: The Photographer and the Model may use the Photographs for **non-commercial purposes**, such as personal use, exhibitions, and contests.
2. Restrictions:

- a. Commercial Use: Neither party may use the Photographs for any commercial purpose, including but not limited to advertising, endorsements, or the sale of merchandise, without the express written consent of the other party. ***Any unauthorized commercial use of the Photographs, particularly for-profit use without such consent, may subject the infringing party to legal action, including claims for copyright infringement and damages.***
- b. Offensive Use: Neither party may use the Photographs in a manner that is obscene, defamatory, or otherwise offensive.

3. Credit:

- a. Photographer Credit: The Model agrees to provide credit to the Photographer whenever the Photographs are used, by including the Photographer's name or business name in a clear and conspicuous manner.
 - b. Model Credit: The Photographer agrees to provide credit to the Model whenever the Photographs are used, by including the Model's name in a clear and conspicuous manner.
- 4. Release of Liability: The Model hereby releases and discharges the Photographer from any and all claims, demands, actions, causes of action, damages, costs, or expenses arising out of or in connection with the use of the Photographs, including but not limited to claims for defamation, invasion of privacy, or right of publicity.
 - 5. No Compensation: The parties acknowledge and agree that this is a Time for Print (TFP) arrangement, and that neither party shall receive any monetary compensation for their services.
 - 6. Governing Law: This Agreement shall be governed by and construed in accordance with the laws of the State of Georgia.
 - 7. Entire Agreement: This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior or contemporaneous communications, representations, or agreements, whether oral or written.
 - 8. Severability: If any provision of this Agreement is held to be invalid or unenforceable, such provision shall be struck from this Agreement and the remaining provisions shall remain in full force and effect.
 - 9. Waiver: No waiver of any provision of this Agreement shall be effective unless in writing and signed by the party against whom the waiver is sought to be enforced.
