This Model Release (the "Agreement") is made and entered on (today's date) _____ by and between Aydin B. Photography (the "Photographer"), and The Model listed above (the "Model") collectively referred to as the "Parties" The Parties agree that they are performing their respective services in a joint collaboration constitutes valuable consideration and agree to the following:

1. Nature of the Shoot: The Parties agree that any images published in any format, including digital or print, shall be limited by the scope of the agreement of the parties. Any images that are created that fall outside the scope of the agreed nature of the shoot must be destroyed immediately. The photoshoot contemplated by the Parties includes the following: ****Mark all that apply***
 - a. Nudity, where nudity is defined as visible or partially visible genitalia, pubic hair, vulva, buttocks, or any part of the nipple or areola.

 - b. Partial nudity, where the Parties agree that only the following may be visible in an image: [cross out what is not contemplated in the photoshoot] genitalia, pubic hair, vulva, buttocks, or any part of the nipple or areola.

 - c. Implied nudity, which is defined as a photoshoot where the Model will be posed or lit in a way to not have any visible nudity as described in 1(a) or 1(b) in any image.

 - d. Censored nudity, which is defined as any nudity as described in 1(a) or 1(b) which is publishing an image in any digital or print form.

- f. Anonymous, where the image is captured, cropped, posed, or lit in a way to hide the Model's face or any identifying features such as tattoos.

2. Commercial Use: The Parties agree that the images created in the photoshoot may only be used in their respective portfolios, which may include portfolios used to solicit paid work, including but not limited to websites, social media, and other promotional materials to showcase their work. However, commercial use (using an image for monetary gain or in exchange for any item of value), including the selling of digital images or prints, or the use of an image that is available only by subscription (regardless of whether the subscription is free), is prohibited.

- a. Neither party may use the Photographs for any commercial purpose, including but not limited to advertising, endorsements, or the sale of merchandise, without the express written consent of the other party. *Any unauthorized commercial use of the Photographs, particularly for-profit use without such consent, may subject the infringing party to legal action, including claims for copyright infringement and damages.*
- b. Any commercial use must be documented in advance below, or covered under a separate agreement:

- c. Offensive Use: Neither party may use the Photographs in a manner that is obscene, defamatory, or otherwise offensive.

3. Attribution and Use of Name:

- a. Unless otherwise agreed to in writing, the Parties must use proper attribution (tagging, and/or identifying the other party in the caption) to the other when posting an image on social media unless the image contains nudity as described in 1(a) or 1(b) above. ***For images that contain nudity, the Photographer must obtain written consent before using the name or social media handle of the Model. Written consent may be in the form of an email, message, or other form of written communication.***

A. Photographer Credit:

1. For all safe for work (SFW) photos, please attribute photos to **@aydin.photos**.
2. For all not safe for work (NSFW) photos, including but not limited to boudoir, implied, nude, or erotic, please attribute photos to **@ulimited.boudoir**.

B. Model Credit: Photographer agrees to attribute photos to the social media handle(s) provided above.

4. Release of Liability: The Model hereby releases and discharges the Photographer from any and all claims, demands, actions, causes of action, damages, costs, or expenses arising out of or in connection with the use of the Photographs, including but not limited to claims for defamation, invasion of privacy, or right of publicity.

5. Compensation Rights: The Parties acknowledge and agree that this is a Time for Print (TFP) arrangement and as such the Parties release each other from any demand of payment and that neither party shall receive any monetary compensation for their services.
6. Editing images:
 - a. The Photographer reserves the right to edit any image created during the photo shoot pursuant to his or her creative discretion.
 - b. The Model may edit an image only if he or she receives written permission from the photographer (*Minor edits such as adjusting lighting, adding social media filters, or reasonable cropping for social media is acceptable and does not need written permission).
 - c. The images may not be edited by either Party to change the agreed nature of the photo shoot, i.e. adding vulgar or derogatory text, editing or deleting undergarments, etc.
7. **Revocation of Rights: For any image that contains nudity as described in 1(a) or 1(b) above, the Model may demand at any time and for any reason that the image be removed, censored, or edited in a way to remove any visible nudity. Likewise, the Model may request that her name or social media handle be removed from any image. The Photographer agrees to perform the requested change as soon as is practically possible.**
8. Governing Law: This Agreement shall be governed by and construed in accordance with the laws of the State of Georgia.
9. Entire Agreement: This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior or contemporaneous communications, representations, or agreements, whether oral or written.
