



AuthentiCare

With all the updates recently to the AuthentiCare clock-in system, we want to take a minute to remind you about the Place of Services codes. There are only two codes listed that should be used by those working for an HCBS Self-Directed individual:

12 - Home



99 - Other place of service

No other Place of Service codes will be accepted. Choosing the wrong code could result in non-payment of time clocked

in. If the worker chooses the wrong code, please reach out to us immediately to get that corrected.

BACKGROUND CHECK RE-RUN POLICY

New hires must clear five different background checks with the State of Kansas before they can be hired and paid through the HCBS program. These are completed and paid for by Life Patterns Inc. It is State-mandated that these background checks be re-run every two years after the date of hire.

Background check forms will be mailed or sent to the individual receiving services, or their representative, for the workers to complete. Failure to return these requested forms by the due date listed in the attached letter will result in the worker not being able to work until they re-clear them again. Please take note of all correspondence from Life Patterns Inc, and address as requested, to mitigate gaps in services.

TAX INFORMATION

The deadline to file your 2024 taxes is April 15th, 2025.

IRS Notice 2014-7

This is not new information but likely to apply to some of our families. In 2014, this notice was to provide information on how the federal income tax was to treat certain payments to individual care providers under state Medicaid HCBS waivers for reporting requirements. It states that payments may be excludable from income. Please talk to your tax preparer to see if you are eligible to exclude your income for the 2024 Tax year from Federal Income tax.

SPRING BREAK HOURS & PLANNING FOR NEW ATTENDANTS

As we patiently wait for spring to come, there is an opportunity for planning. Spring break is just around the corner and will be here in a moment. If you and your family have any plans during this time that would require a new attendant, don't wait for the last minute to get the process started.

Our hire packets can be found on our website at <u>www.lifepatternsks.org</u>, they can be picked up at our locations in both Topeka and Montezuma, and we can email them to you directly.

Once we receive a completed packet (with the **original I9** form received by your respective office with Life Patterns), we will start the background checks for your new worker. Background checks can take four days to two weeks to come back. When those are cleared, your worker will be assigned a worker ID to begin clocking in with. There is no back pay for time worked before a worker ID is assigned.

2025 W2 Information

Life Pattens Inc. sent all 2024 W2s out on January 27. If your workers did not receive theirs and have moved without sending us an address change form, please have them complete one and return to us immediately. Those forms can be found on our website: www.LifePatternsKS.org.

2024 W2s are available where paystubs are accessed on our website. This will be the quickest way for someone who has lost or never received their W2 to get it. If your worker has never accessed their paystubs and needs access, they can reach out to have the information to set that up emailed to them.

If there is no way for the worker to access our paystub portal and they need to have the W2 reprinted, then they can contact our office to have that done, as long as we have the correct address on file. Reprints will start on Friday, March 7, and will be done weekly after that.

Federal Budget Proposal may affect Medicaid

The Federal Government has put forth a budget draft that will cut funding, and this could affect Medicaid programs, according to Politico, a global news outlet. This could shift the costs of Medicaid Services directly to the states, likely forcing them to cut rates or reduce services.
