V. Current Business: Ron

- i. 2023 elections. -got off to rough start due to no written guidelines, need something in writing. Election committee will continue voting until November 30, with results announced immediately afterwards. Online voting was easy.
- ii. SOP review. -committee reviewing SOP and Bylaws for needed changes. Details to be discussed at a later meeting.
- iii. Recognition awards. -it was voted and approved to allocate \$200/yr to provide small awards, such as a \$10.00 gift card, for small events-like ramp builds. It was mentioned that after street cleanups, all names are put in a hat and a gift certificate is awarded to one participant. The purpose is to offer immediate recognition, award positive behaviors. Discussed possibly having a get together in January to give out recognitions.
- iv. Distributed Club roster. See separate handout. -a sample club roster was circulated indicating the information that will be included in the roster made available to the board. Members will be given the opportunity to indicate what information they want included in a roster made available to the entire club. Members will have the opportunity to opt out of having their info included. An email will be sent out, members who do not reply will only have their name included.
- v. Board meeting exclusion. -Captain reached out to other clubs for input and it was the consensus that board meetings should remain open to all members. It was decided to use a card system to keep board votes private. If the need arises to have a closed meeting, the board will do so at separate time.
- vi. Club property. Discussed that, how to handle Club Property will be added to the SOP and will include a sign out sheet for members to borrow club resources, condition of property when returned, and that it will be the responsibility of the member who borrows the resources to retrieve and return what they borrow.
