I. Call to Order: Ron – Called to order at 6:32 pm

II. Opening Remarks

- i. Cap'n Ron Thanks for coming and being on the board. Missing board members had previous commitments and unable to attend rescheduled meeting.
- ii. Board Members No opening remarks from attendees.
- iii. Other Members -No opening remarks from attendees.

- **III. Approval of July minutes:** Ron Motion made and seconded to approve July minutes, all approved. Captain received verbal approval from absent members.
 - IV. Club Finances: Susan- The annual budget was amended to include \$1200 for FL Cares per the last board meeting. The new budget shows a potential net profit of \$1700.
 - i. Present revised annual budget. Waiting on decision of participation in the Winter Festival.
 - ii. Present financials. Purchasing the feathers was discussed, awaiting updated quote and design to decide whether to purchase 1 or 2.
 - iii. Phrenzy. Currently we have collected approximately \$22,000 for Phrenzy with some monies remaining to be collected. Deadline of Sept 30 to collect all monies. Date and place to present check to Alzheimer's Project will be determined. Suggestion made to investigate the possibility of presenting the check on TV. Chairman will check into this. Discussed for next year not to offer giveaways such as the cups because not everyone got one and several left on tables. It was suggested using the ones we have remaining to give out to new members. Other concerns discussed were the lack of volunteers, how to entertain and keep comfortable those who arrive early before the doors are open and the need for the pre-party. It is important to remind members that the Phrenzy and the other events (excluding monthly socials) are necessary for since the club retains 8% of gross proceeds for business operations, allowing us to continue to thrive as a club.

V. Membership: Mary Grant

- i. Report on TPHC membership. Currently have 142 paid members, of those 1 is deceased and 6 have moved so have 135 "active" members, with a few additional expected to join in October. During summer socials, we averaged 20% of membership in attendance.
- ii. Leadership Conference. Two members attended the PHIP's Leadership Conference. Received handout of highlights. It was discussed that PHIP is in process of upgrading their Website that will allow other clubs to use their domain for free, we currently pay a fee for our website. The use of social media was encouraged to promote your club, so all are asked to increase our presence on social media, like You Tube, Instagram and Facebook. Discussed a merchandise program we can join to save on club merchandise we order.

VI. Current Business: Ron

- i. SOP review. Committee reviewing and will present suggestions by 9/30. Revised SOP will be presented to board members once completed.
- ii. Winter festival. Cost for booth is \$325 so it was decided not a good idea. Will obtain further information about the possibility of just driving a vehicle in the parade and members walk along or possibly getting the Landshark vehicle. Also discussed just simply handing out business cards about the club. More information to follow.
