



## Promotional Discount Terms and Conditions

### 1. Eligibility

1.1. Promotional discounts, offers, or price reductions (“Promotions”) displayed on the GEODEC Limited website, social media platforms, or any official GEODEC Limited marketing materials are valid **only** when a consultation or quotation is **booked directly via the GEODEC website** at [www.geodec.co.uk](http://www.geodec.co.uk).

1.2. To qualify, the Client must complete and submit the online booking or quotation request form in full.

1.3. GEODEC Limited must acknowledge and confirm the booking in writing (by email or written confirmation) before any discount is applied.

1.4. Promotions are **non-transferable, non-negotiable**, and apply only to the individual Client named on the booking confirmation.

### 2. Application of Discounts

2.1. Promotional discounts apply **only to new quotations** requested and confirmed during the valid promotional period stated.

2.2. Unless expressly stated otherwise, all discounts apply to **labour costs only** and exclude materials, travel, parking, equipment hire, or subcontracted works.

2.3. Only **one promotion** may be applied per project or booking. Promotions cannot be used in conjunction with any other offer, referral scheme, price-match guarantee, or loyalty reward, unless expressly agreed in writing by GEODEC Limited.

2.4. Discounts cannot be back-dated or applied retrospectively to quotations requested prior to the promotional period.

### 3. Exclusions and Limitations

3.1. Promotions are **not valid** for:

- Enquiries or bookings made via telephone, email, social media, or third-party platforms.
- Existing or ongoing projects.
