General Information & Rules

Date: Saturday, November 2, 2024
Time: 11 AM – 3 PM

Setup: Vendors will start at **8:00 AM** the day of the festival. Please be on time to reduce any traffic congestion in the event area during set-up. **All vehicles/trailers must be removed from the festival area by 10:30 AM, NO EXCEPTIONS** (Parade time starts at 11 AM) vehicles will not be allowed to enter after that time.

Disassemble Time: No earlier than 2:00 pm unless granted by event staff.

Booth Spaces (10x10): Each participant is responsible for their own set up (i.e. water, electricity, tables, chairs, tents, etc). Only approved vehicles will be allowed to remain within the event grounds.

Booth Fees:

INFORMATION ONLY:	No charge
NON-FOOD ONLY:	\$25.00
ANY FOODS/DESSERTS/ETC:	\$50.00
FOOD TRUCKS:	\$75.00

Rules:

Vendors may be limited by booth type on a first come, first serve basis.

Only one booth allowed per application fee (If you need additional booth space, each will carry its own application fee. No sharing of booth space.)

You will only be permitted to offer the items or services listed on your application. If there is a conflict with these guidelines you may be asked to exit the event grounds.

No electricity or running water is available at vendor site. Please let us know if you plan to bring a generator.

Vendors are responsible for removing all belongings and trash from the vendor site at the dissemble time.
