A special Thank You to all the businesses who donated door prizes for the day!

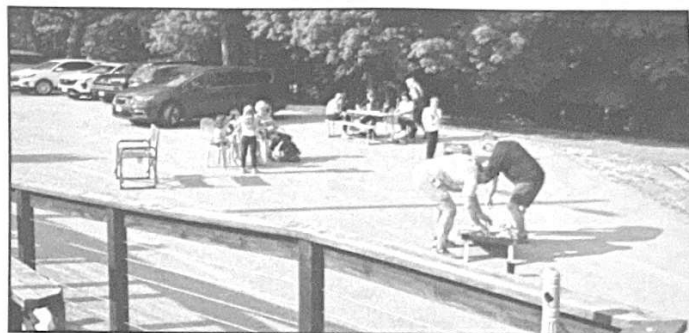

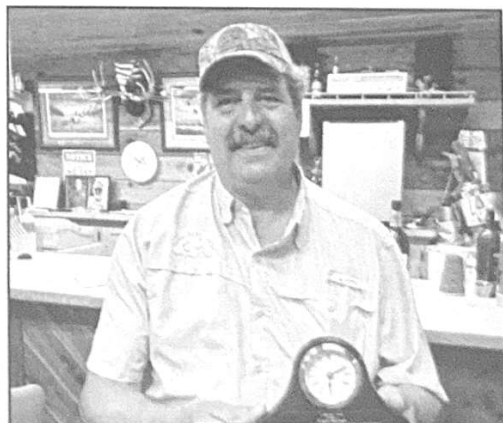
