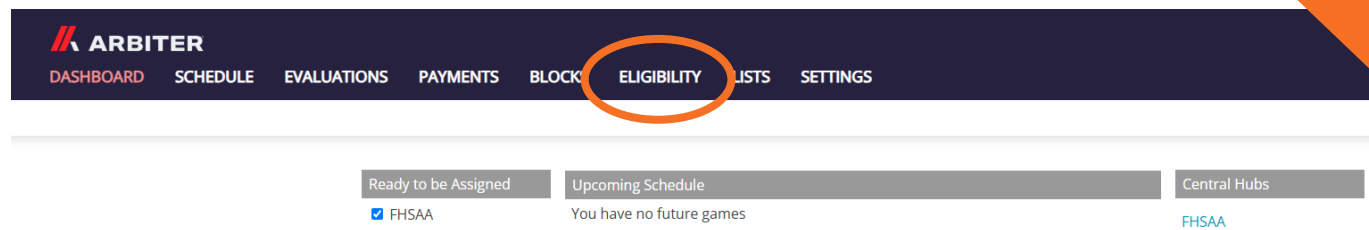
Step One:
