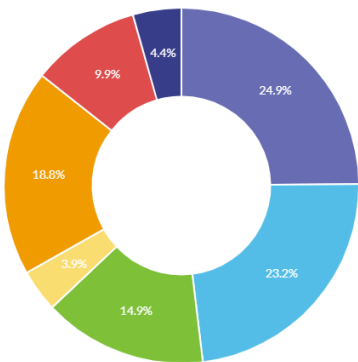

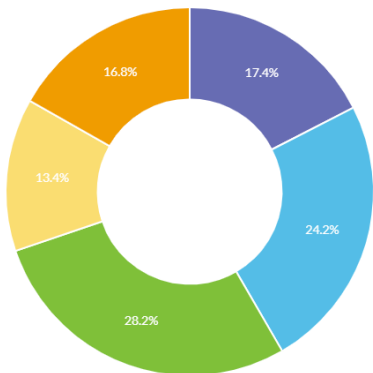
What type of training would you like to see more of in our General/Training meetings. Select all that apply.

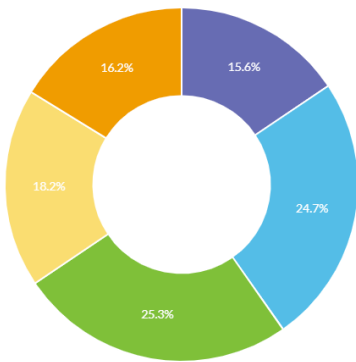
