



## *2025-26 Policies & Waiver Signed at Time of Enrollment*

These policies and waiver/release of liability have been signed by the parent/guardian at time of online registration and will be upheld throughout the season. You may reference this document to review what you have signed in case you have any questions. You are more than welcome to contact Noa with any additional questions or clarifications. If there is a conflict of any kind, Noa will reference back to these policies you have signed. Exceptions to these policies are not to be expected. Highlighted policies are very important. Thank you for your cooperation.

## ***Tuition Due By the 20th of the Month Prior***

I understand and agree to pay my monthly tuition by the 20th of the month prior. If paid between the 21st and 30th/31st of the month, I will be charged a \$10 late fee. No exceptions. Lastly, if it is not paid by the 1st of the month and the card on file is not going through, I will be dropped from the class and NMG will continue to charge the card on file for the full month of tuition and late fee until it is paid. Emails and letters will continue to be sent until my balance is paid. My child may not attend until it is paid. I understand that for August 2025 tuition, no fees will be considered late as long as they are paid by August 9th. This is the only month with this exception.

## ***Drop Class Policy***

I understand that I must let NMG know in writing (email or text) that I want to unenroll or drop a class by the 20th of the month prior to the month I am dropping. If I want to un-enroll for October class, I must let NMG know in writing by September 20th. If I do not let NMG know by the 20th of the previous month, I am still enrolled and still owe tuition. I understand I have a grace period of the 21st through 30th/31st to drop a class BUT I will still owe 50% of tuition and the \$10 late fee. Lastly, the grace period ends on the 30th/31st and I will owe full tuition and \$10 late fee on the 1st even if I want to un-enroll. I understand these policies will be enforced and I agree to following these policies. I know to avoid any fees, I need to un-enroll by the 20th of the month previous to the month I am dropping. I understand there are no exceptions to this policy and I will not receive refunds.

## ***Late Fee Policy***

I understand that if I turn in my monthly tuition after the 20th of the month prior, I will be charged a \$10 late fee. I agree to paying this late fee. Any payment that is late will include the late fee, no exceptions. I understand and agree to follow this policy.

## ***Credit Card Filing/Charging Policy***

I am required to enter my credit card information into the parent portal at time of registration. Even if I choose to pay my tuition in alternate methods, my card must be on file. If my card expires, I will go into the portal and update it. I give Noa

Marting Gymnastics permission to charge my card on file in the circumstances that I do not pay my tuition on time. I understand that tuition is due by the 20th of the month prior. I understand that my card on file will be charged as early as the 21st if I do not pay my tuition myself. I understand my card will continue to be charged if it declines until the transaction is approved. I understand that there are no refunds.

### *Missed Class Policy*

I understand that when my child(ren) is absent from a class, I do not receive any type of refund or discount to my monthly tuition. My monthly tuition holds my spot whether or not my child(ren) is present or absent. I understand and agree to this policy.

### *Gym Cancellations Policy*

I understand that NMG cancels during the following holidays; Fourth of July, Halloween, Thanksgiving, Christmas Eve, Christmas Day, New Year's Eve, New Year's Day, Labor Day and Memorial Day. These are scheduled cancellations due to holidays so I understand there are no makeups for these missed classes or refunds. In addition, NMG cancels during Christmas break. The Christmas break closure for 2025 is Wednesday, December 24th through Thursday, January 1st. I understand and agree with the information regarding gym cancellations.

### *Makeup Policy*

I understand and agree that makeups are not guaranteed or included in my tuition. They are simply a "bonus" when it works within the gym's schedule. Students are allowed 1 makeup per month per class if it fits into the gym schedule. A student has 30 days from their missed class to attend a makeup class if they wish to (and if it fits into the gym's schedule). For example, if Sally was absent on January 5th, she has until February 5th to complete a makeup class if she wishes too. After February 5th, that makeup class for January 5th is no longer available.

### *Weather Cancellation Policy*

I understand and agree to the policy that NMG does not follow the Independence School District weather cancellations. NMG will announce via email and Facebook if they are canceling due to inclement weather. I do not get makeup classes for

weather cancellation if NMG cancels. That means I may **not** makeup a class if it was canceled due to weather. If I choose not to come when there is bad weather, I may use my 1 makeup pass to make up the missed class.

### *Image/Video/Social Media Release*

I agree to the following: Noa Marting Gymnastics has my permission to use my or my child's image publicly to promote the Gymnastics facility. I understand that the images/ videos may be used in print publications, online publications, presentations, websites, and social media (including but not limited to; Facebook, Instagram, TikTok, etc.). I also understand that no royalty, fee or other compensation shall become payable to me by reason of such use.

### *Release and Waiver of Liability*

I agree to the following: In consideration of participating at Noa Marting Gymnastics, I represent that I understand the nature of this Activity and that my children are qualified, in good health, and in proper physical condition to participate in such Activity. I understand that all class times, coaches, and prices are subject to change without notice. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue my children's participation in the Activity. I fully understand that this Activity involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my children's own actions, or inaction's, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "releases" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, cost, and damages I incur as a result of my children's participation in the Activity. I hereby release, discharge, and covenant not to sue Noa Marting Gymnastics, its respective administrators, directors, agents, officers, volunteers, employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) from all liability, claims, demands, losses, or damages, on my account caused or alleged to be caused in whole or in part by the negligence of the "releasees" or otherwise, including negligent rescue operations and future agree that if, despite this release, waiver of liability, and assumption of risk, I, or

anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage, or cost, which any may incur as the result of such a claim. I have read the RELEASE AND WAIVER OF LIABILITY, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect. AND I, the minor's parent and/or legal guardian, understand the nature of the above referenced activities and the minor's experience and capabilities and believe the minor to be qualified to participate in such activity. I hereby release, discharge, covenant not to sue and AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS each of the Releasees from all liability, claims, demands, losses or damages on the minor's account caused or alleged to have been caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations, and further agree that if, despite this release, I, the minor, or anyone on the minor's behalf makes a claim against any of the above Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS each of the Releasees from any litigation expenses, attorney fees, loss liability, damage, or cost any Releasee may incur as the result of such claim.

### *Medical Release*

Consent of Treatment of a Minor Should it be necessary, in the opinion of a staff member of Noa Marting Gymnastics to render first aid and assistance to the participant(s) listed above, I hereby grant permission to the staff of Noa Marting Gymnastics and other medical personnel to render such aid and assistance as they may deem necessary. I have carefully read this consent for treatment of a minor and fully understand its contents.

### *Expectations 25/26*

I agree to and understand the following expectations:

**Tuition:** Pay tuition by the deadline. Pay late fee if tuition is late. Read and follow all tuition policies

**Absences:** Mark absences in the portal, you do not need to send a direct message to Noa. Communicate to Noa if interested in making up a class (1 per month).

**Preparing for Class:** Have your child use the restroom before class. If your child can not use the restroom on their own, you will need to stay in the lobby to help them. Send child with a water bottle. Send child in appropriate dress. Arrive in a timely manner

**During/After Class:** Parents may choose to watch class in the lobby via the camera/television system or drop off and pick up. Parents/guests/siblings are not allowed into the gym space (besides Tumble with Me class). Parents must stay in the lobby during class if their child needs assistance using the restroom. Students under the age of 12 are not allowed to leave the gym lobby alone without an adult. You must come into the lobby to pick up.

**Communication:** All questions and concerns are directed to Noa Marting via email, phone, text, or NMG Facebook/Instagram. Do not direct message other coaches.
