4. Financial report

The financial report to January 31, 2025, was presented as part of the review of the AGM package.

5. **Gardening report**

Dave will follow up with asking the gardeners for a formal quote for fence and drain rock repairs/replacement.

6. **Maintenance reports**

- **Gutter cleaning**: We were quoted \$5,500 for the recent gutter cleaning/repairs, but negotiated down to \$4,000 due to it taking much less time than anticipated.
- Intercom: There is no update on the cost/quote, but a resolution will be presented at the AGM for upgrades. Some units are still reporting that their intercom is not working, but most are, so it seems to be a connection problem with those individual units. We suggest checking for conflicts with cable/telephone internet connections.
- **Snow**: Nick S. and Don Baker spread some ice melt on the driveway and walkways before the snow, and it seemed to work well, with minimal shovelling needed.
- **Elevator:** Richmond Elevator attended today to fix the left elevator that was out of service.

7. Review of draft AGM package

We reviewed the revised draft of the AGM notice/meeting package, including the 2025/26 budget and strata fee schedule. Some items that were higher than usual were outlined, as discussed at the January 3 council meeting. The notice will be finalized and distributed by February 10, 2025.

8. Correspondence and bylaw infraction letters
