### 4. Financial report

#### 5. Gardening report

#### **Maintenance:**

- Fire alarm testing is being booked. We have quotes from DSN Safety at \$1,495 plus tax and from Mircom at \$4,080 plus tax.
- Carpet cleaning has started.
- Cleaning of parkade has started.

- Quotes for repairing patio on SL#45 will be obtained.
