

Rules

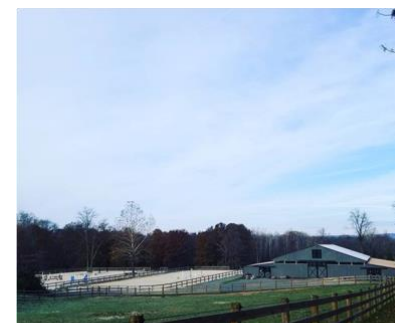
1. All horses must have a negative Coggins to be on show grounds. This applies for companion horses also.
2. All riders must wear protective ASTM/SEI approved head gear.
3. Windswept Acres2 LLC, Ken Zimmerman, employees, etc. **WILL NOT BE HELD RESPONSIBLE** for any damage, injury, or loss to persons, horse/pony or property of exhibitor or spectator incurred on or off the show grounds. It shall be a condition of entrance to the grounds that this is agreed.
4. Windswept Acres2 LLC, reserves the right to cancel, combine or otherwise alter classes.
5. Show management reserves the right to excuse any horse that is visibly unsound or in ill health, as well as any rider who demonstrates unsportsmanlike behavior.
6. No draw reins permitted in classes.

7. Schooling in ring available 7:45 AM-8:45 AM and as indicated in schedules. Schooling breaks are ten minutes only; there will be a warm up ring available.
8. Refreshments will be available on the grounds.
9. All dogs must be leashed.
10. Six ribbons will be awarded in each class; Champion and Reserve ribbons in each division.
11. Fence heights are approximate.
12. The decision of the judge is final.
13. There will be a \$15 schooling fee for all horses not registered in a class
14. There will be a \$5 EMT fee.
15. If you have a fever or are feeling ill please DO NOT ATTEND!
16. PLEASE practice safe social distancing practices.
