Avis De Déclaration

We, The Citizens Of Canada, are governed by a political party espousing a political ideology of its own, we recognize and assert said party's authority arises **ONLY** from the **CITIZENS** of Canada and not from persons or entities external to our country who have no vested interest in the preservation of Canada and may not hold the same political, ideological, ethical, moral and philosophical views as Canadians as set out in The British North American Act, 1867.

While we recognize that all persons home and abroad have individual rights, we assert they also have individual responsibilities in accordance with natural law.

WE, THE CITIZENS OF CANADA, will no longer surrender our natural, fundamental and acquired rights under laws, duly enacted under the authority of the Citizens of Canada, to the will of an unelected global authority.

Under the UDHR Articles 2 & 7 we release the Nation of Canada and it's rightful citizens from all binding, and non binding agreements, which **do not comply with our National or Human rights**

Whereas Canada is founded upon the following principles:

- Supremacy of God
- equality of individual right and individual responsibility
- the right to work towards individual goals, promoting health, liberty, and happiness of ourselves and our fellow citizens,

We recognize the limits of our abilities and resources to accommodate the demands of the world and do not consent to the depletion of our resources without our consent to others outside of our borders such that we, the rightful owners of said resources, are placed in a negligible or vulnerable position.

The form of government to preside in Canada is that of a free market democracy wherein all are considered equal, and having the same rights and responsibilities.

While individual rights are fundamental, so too are individual responsibilities for oneself. The rule of law will prevail in the case of a conflict between rights and responsibilities. Said law having been duly enacted by a legitimate government representative of the people, elected in accordance with the Westminster Parliamentary System. Power and authority of any sitting government is derived from the people.

Government may be recalled at the request of the people and impeachment of any party leader or member may occur by petition of the people said member represents. In the case of a party leader, said leader may be recalled by members of their party at the discretion of party members at any time. An appearance of conflict of interest shall be deemed a conflict of interest, whether or not it is in actuality a conflict, requiring any member of parliament to step down forthwith.

No politician is protected by their office against criminal charges of any kind and shall be held accountable for their actions in accordance with governing law at **twice the penalty**, as they were in a position of public trust at the time

Forthwith, We, the Citizens and People of Canada, will no longer surrender our natural, fundamental, acquired and God-given rights to the sitting Government of Canada. No longer do we, the Citizens, People and Permanent Residents of Canada grant them authority over us – its authority is hereby revoked.

Canadians are the rightful owners and shareholders of Canada and require the following from their government, in a **timely fashion**:

- an independent and fully transparent investigatory tribunal into the criminal activities of all **United Nations policies** and representatives, **political representatives, banking systems, alleged Corporate Crimes, NGO's**, and any so-called **non-binding agreements** related thereto;
 - An immediate halt to any and all illegal and or 'pay to play' migration and immigration;
- a moratorium on all International Banking Agreements as well as a full, transparent and comprehensive investigation of same;
 - an immediate end to Foreign Austerity measures;
- Implementation of **Canadian Citizen Initiated Referendums** for all issues effecting National Canadian issues under the purview of the federal government as per the British North America Act, 1867, such as **transportation, taxation, monetary policies, inter provincial transfers, foreign investment, and foreign aid**;
 - an immediate moratorium on 'Blood Oil', subject to tribunal investigations;
 - an **immediate moratorium** on foreign infrastructure investment, instead focusing on Canadian infrastructure improvement
- immediate investigation** into Huawei, 5G dangers and hazards, both long term and short term, as well as personal security and safety therefrom with complete transparency and a full report made to the public in a timely manner.

- In the event the UN is uncooperative with respect to investigations of the aforementioned areas of concern, we the Citizens of Canada further demand Canada's withdrawal from the United Nations and all funds paid for future membership or benefits, shall be requested to be returned to the Nation of Canada by the United Nations forthwith.

-In the event the United Nations refuses to return funds already received from the Nation of Canada for future fees, gifts and donations, a full investigation and examination of the monetary practices of the United Nations in the World Court is requested.

Upon reading this you are considered notified of the peoples will, this is the moment in time of your opportunity to stand of the peoples will or against it. No opportunity to plead ignorance of the will of the people will forthwith be accepted
