A Cry for Impeachment

Rush Limbaugh said he would love to see Obama impeached (realizing the clear case for it), but being the first black president, it would never happen! Which means, pathetically, that at least one color trumps honest thinking, due cause, and justice!

Because, of course, Obama and his cronies would play the race card to its full advantage. That's how he got into office, and how he stays in. Forget ethics and integrity. For him, race is job insurance that doesn't cost him anything, but it costs the country all the negative, destructive results of his deliberate, unconstitutional misuse of authority, and various other devious actions to advance his socialistic ideology.

The Constitution, especially as its principles are applied in conjunction with the Declaration of Independence, clearly delineates his disloyal, and criminal conduct! Abraham Lincoln referred to that precious document as a "Statement of principles, through which the United States Constitution should be interpreted".

Which, leads me to note certain very applicable advice in that document, regarding action that is warranted by presidential misconduct: "All men are endowed by their Creator with certain inalienable Rights, that among these are Life, Liberty, and the pursuit of Happiness.....But when a long train of abuses, and usurpations.....evinces a design to reduce them (the people) under absolute Despotism (dictatorial control),.....it is their right, their duty to throw off such government, and to provide new guards for their future security."

That instruction is more than advice, it is an agreed upon directive to be carried out, in order to prevent a clearly established movement to undermine, and destroy our internationally unique republic, fought for through great personal sacrifice, and by the grace of God. Which form of government, requires that decisions affecting the establishment of laws and regulations are subject to "consent of the governed", or that the supreme power of the nation rests in the citizens, and is

exercised through duly elected representatives, and other appointed officials.

So, that while there should be, and undoubtedly would be, specific offenses worthy of impeachment that leads the people to conclude that that course of action is necessary, a collective desire of the people is enough to depose a president by congressional procedure, without proof of offenses by judicial trial. And, then they may thoughtfully and responsibly elect a successor to that distinguished position, which has been exploited and dishonored by the current turncoat imposter!

It might help to make the point of having a limited, fundamental role of government, to start from the beginning.

(1) The first institution of life is Natural law, or natural rights, which are instinctive, and not to be denied, or restricted, except by mutual agreement to provide equal natural entitlement to property, and necessities and privileges of nature.

(2) Logically, and ideally, regulatory, and penal law is not to be imposed upon people by the will of a governing body. It is subject to the majority will of the people ("consent of the governed"), exercised by representative persons, as agents of the people. Recourse should always be provided to remove, and replace anyone who does not carry out the will of those represented.

And, neither should the process require a technical legal trial, and proof of cause for removal, though such process should find Obama guilty of the enumerated offenses, following. It must be maintained that it is the common province of the people (direct, or represented) to decide what action is to be taken for any public, or civic aspect of their lives.

Never should the free will of man be subject to independent external authority, except God, and those selected to govern, and regulate the mutual civic privileges, and responsibilities of society.

It should always be borne in mind that institutions established by man, for the common good, including the elected and appointed administrators of services are always to be subservient to the will of those who are served. They are not, or should not be, subservient to the forces, or powers that they created to

administrate, and perform necessary governmental services.

That is why the arrogant, dictatorial misuse of delegated authority in a free republic should be resented, and not tolerated. Every infringement upon the natural rights of man is a loss of freedom, and independence that should not be allowed to restrict his life. Whether the matter is major, or minor, the personal rights principle should always be the decisive factor. In contrast, the current administration generally ignores, and increasingly restricts the fundamental, natural rights of citizens!

The following quotation is a beautifully expressed observation by a Christian missionary lady, that is timelessly applicable to everything in life that must be properly understood, and acted upon if necessary: "The eternal significance of a thing, never lies in the thing itself, but in the quality of our reaction to it." Seeing something for what it's really worth, not emotionally, or biased, but objectively, and doing the right thing about it, is what counts in our moral responsibility to God, and our fellow man, as well!

Partial List of 64 Impeachable Offenses Committed by Pres. Obama, Compiled by Internet Archive, in 2010, not including the many additional offenses since.

1. Illegal contributions, to presidential campaign.
2. Census Bureau control, moved from commerce Dept. to the White House, and managed by Rham Emmanuel.
3. Providing de facto amnesty to illegal immigrants by I.C.E.
4. Obama having chair of U.N. Security Council in 2009, violating Constitutional law.
5. Foreign policy that turns away U.S. allies, and embraces our enemies.
6. State Dept. use of \$23 million dollars in taxpayer money, to help transform Kenya into a communist nation.
7. Instigating violent overthrow of religiously tolerant, U.S.--friendly Kenya.
8. Giving aid and protection to terrorists in Kenya.
9. Failing to hold press conferences to answer for his progressive policies and actions.

10. Taking control of million of acres of public and private land, without input from Congress, state and local officials, and land owners.
11. Damaging relations with Israel by contrary actions.
12. Fraudulent use of SSN's in documents.

Referring to charges of unauthorized use of Executive Orders, which are permissible when confined to legitimate areas of executive discretion, and administration of the law. The instruments are NOT legitimate as a way of making new laws. Such actions are incidences of flagrant disregard, and disrespect for the separation of powers instituted to prevent that very problem.

That is where Obama is radically different than other presidents. He uses Executive Orders, and administrative decrees issued by his cabinet officers, or their subordinates to create new law, which is a power delegated to Congress by the Constitution. At least eighteen times, Obama has unilaterally committed such unlawful acts. Examples are:

1. Re-writing of the Affordable Care Act.

2. Implementing the Deferred Actions on Deportations program in June 2012. When Congress had voted to reject that so-called "Dream Act", Obama acted in defiance of Congress, and instead of an unauthorized Executive Order, he ordered it done by a junior appointee in the Department of Homeland Security.
3. He refused to halt aid to Egypt, which Congress had made a resolution to suspend.
4. He was subject to possible criminal actions, in covering up the IRS scandal of harassment, and denial of approval of tax exempt status for conservative Non-Political Organizations, and for his own role in the Benghazi fiasco.

Intervention action is required by the House Republican leadership, in the foregoing, yet unprosecuted constitutional violations.

The "race card" notwithstanding, justice cries out for the execution of impeachment action against President Obama, before further damage may be done against our country, by more of the incomparable traitorous and treasonous abuse of office, of which he has been egregiously guilty!

Black or white, right is right, and every effort should be made to apply the full weight of constitutional law against treasonous acts ('high crimes and misdemeanors'), which flagrantly and defiantly abound in Obama's "reign".
