9/11 WTC False Flag Tragedy An Indisputable Act of Conspiracy

- 1. Fifty of the world's leading physicists all stated that it is impossible for fire to cause the collapse of a steel frame building. In fact, no such results have ever occurred!
- 2. Only a pre-arranged controlled demolition plan could cause such buildings to implode and collapse.
- 3. WTC building 7 was not struck by a plane, and steel columns fell in 30 ft. lengths (the demolition trucks' body length). Coincidence?
- 4. The columns were hauled away the next a.m., illegally removed without forensic examination, and shipped to China, to

remove evidence of the subversive high crime!

- 5. Outside wall concrete was pulverized, which fire could not do.
- 6. Columns were cut off in place with special chemical material (thermite?), which can cut through steel like a knife through butter.
- 7. The Towers were built to withstand 160 mph winds, and the crash of a 107 plane (not much smaller than a 767). No significant effect was found on perimeter columns, or core structure. Nothing was displaced.
- 8. A decision by Silverstein, the lessor, and the Fire Dept.was made during the events to pull down (demolish) WTC 7 (which had already been scheduled for removal per Urban Renewal Project).
- 9. The towers, per Commission false report were said to be weakened--yet photos and videos show both towers to be stable, and motionless after impacts.
- 10. Floors, made of strong constructed grids of steel, versus "lightweight truss" systems (reported by the government 9/11 Commission).
- 11. It would be virtually impossible for aluminum planes to crash through the outer walls of the towers! Cameras observed explosion flashes (gigantic fireballs) just before impact, which made holes in the buildings. Hence, there is no way the planes

could ever do that much damage, by mere impact.

12. Unanswered questions submitted by family steering committee credible witnesses, whose testimonies were ignored by the 9/11 Commission, and the mass media.

In summary, the 9/11 Commission's "findings" are a classic example of our government's systemic practice of obfuscation, "fake news", and propaganda, as in the following oversimplified false quote from their Report: "The 9/11 attack was driven by Usama Bin Laden. We now know that these were carried out by various groups of Islamic extremists."

A correct account of the assault was that even though the Islamic terrorists were employed in the attack as a "false flag" subterfuge, the real cause of the incidents was the NWO conspiratorial U. S. Government complicity, as proven by the conclusive incriminating evidence cited, heretofore.
