MEASURED GOLF FACILITY PASS OPTIONS

THE STANDARD PASS

UNLIMITED ACCESS TO FACILITY VIA PIN NUMBER
UNLIMITED TRACKMAN RENTAL*
UNLIMITED ACCESS TO THE INDOOR SHORT-GAME AREA INCLUDING THE WELLPUTT
FOUR SINGLE-USE GUEST PASSES PER MONTH
ACCESS TO THE STACK SPEED TRAINING PROGRAM
\$100 OFF MONTHLY COACHING PROGRAM

\$4,500 PER YEAR, OR \$400 PER MONTH WITH A 6-MONTH MINIMUM COMMITMENT

THE COLLEGE PASS

UNLIMITED ACCESS TO FACILITY VIA PIN NUMBER
UNLIMITED TRACKMAN RENTAL*
UNLIMITED ACCESS TO THE INDOOR SHORT-GAME AREA INCLUDING THE WELLPUTT
FOUR SINGLE-USE GUEST PASSES PER MONTH
ACCESS TO THE STACK SPEED TRAINING PROGRAM
\$100 OFF MONTHLY COACHING PROGRAM

MUST BE CURRENT COLLEGE STUDENT TO QUALIFY
\$1,500 PER SEMESTER AND OR \$750 FOR SUMMER BREAK

THE JUNIOR PASS

UNLIMITED ACCESS TO FACILITY VIA PIN NUMBER
UNLIMITED TRACKMAN RENTAL*
UNLIMITED ACCESS TO THE INDOOR SHORT-GAME AREA INCLUDING THE WELLPUTT
ONE SINGLE-USE GUEST PASSES PER MONTH
ACCESS TO THE STACK SPEED TRAINING PROGRAM
\$100 OFF MONTHLY COACHING PROGRAM

MUST BE 18 YEARS OF AGE OR YOUNGER TO QUALIFY
\$2,000 PER YEAR OR \$200 PER MONTH WITH 6-MONTH MINIMUM COMMITMENT

*3-HOUR MAXIMUM PER DAY

Measured Golf Facility Guidelines

MEASURED GOLF STAFF AND PASS HOLDERS WILL RESPECT EVERYONE'S RIGHT TO ENJOY THEIR EXPERIENCE AT MEASURED GOLF FREE OF JUDGEMENT AND/OR HARASSMENT

MEASURED GOLF PROPERTY INCLUDING PHYSICAL FACILITY AND PROPERTY CONTAINED WITHIN ARE TO BE RESPECTED AND ANY DAMAGE DONE TO SAID PROPERTY IS THE RESPONSIBILITY OF THE PASS HOLDER

DOOR ACCESS CODES ARE INDIVIDUAL AND NOT TO BE SHARED WITH ANYONE

BOTH DOORS TO THE FACILITY ARE TO REMAINED LOCKED UNLESS A MEMBER OF THE MEASURED GOLF STAFF IS PRESENT

THE ENTIRE GYM SPACE, LAB WITH FORCE PLATES, AND OFFICE ARE OFF LIMITS UNLESS YOU HAVE PERMISSION FROM MEASURED GOLF STAFF

ALL TECHNOLOGY RENTALS ARE TO BE SCHEDULED ON THE WEBSITE

LIGHTS ABOVE THE THREE TRACKMAN BAYS ARE TO BE DIMMED TO THE LOWEST SETTING, AND LEFT ON UPON DEPARTURE

COMPUTERS ARE TO BE TURNED OFF THROUGH WINDOWS AND NOT BY POWERING OFF THE COMPUTER TOWER

DATA TILES AND CHANGES TO TRACKMAN SOFTWARE NEED TO BE RETURNED TO HOW THEY WERE PROIR TO ENDING SESSION

IT IS THE RESPONSIBILITY OF THE PASS HOLDER TO NOT DISTURB OTHER PASS HOLDERS WHILE USING THE FACILITY

PASSES ARE NON-TRANSFERABLE AND THE HOLDER SHALL REMAIN THE SAME FOR THE DURATION OF THE PASS

PASS HOLDERS ARE RESPONSIBLE FOR THEIR GUEST

PASS HOLDERS ARE EXPECTED TO LEAVE THE FACILITY AT LEAST AS WELL AS THEY FOUND IT UPON ARRIVAL

ANY DAMAGE DONE BY A PASS HOLDER NEEDS TO BE IMMEDIATELY REPORTED TO MEASURED GOLF STAFF

NO COACHING IS AUTHORIZED AT MEASURED GOLF UNLESS IT IS MEASURED GOLF STAFF

DATA COLLECTION AND STORAGE IS THE RESPONSIBILITY OF THE PASS HOLDER

The Measured Golf pass holder agrees to adhere to the aforementioned facility guidelines and understands that failure to do so can lead to termination of facility pass. Should the facility pass be terminated for any reason, any prepaid funds will be prorated and refunded once the pass holders account is in good standing. Measured Golf pass holders using the monthly payment option will also have 10 days from issue date of the invoice to pay before suspension of their door code to the facility, and 30 days to pay the full amount of the invoice before the suspension of pass.
