Since St. George Christian Academy must make budgetary decisions based upon a projection of enrollment, purchasing supplies and materials, and contracting with teachers and staff based upon enrollment agreements, the School retains a prorated portion of tuition if a family must withdraw before/during the school year.

When a student is withdrawn from the school, whether at the request of the parent or the School, the parents' financial liability for tuition is shown below. When a student enters mid-year, tuition is prorated according to the Delayed Entry schedule above.

COMMITMENT 1

The Commitment to Reading Nightly

Parents/guardians agree to spend time reading aloud with their child(ren) for a minimum of 15-20 minutes every night. Reading will be tracked using a monthly reading log.

COMMITMENT 2

The Commitment to Being Screen-Free

Parents/guardians commit to withholding possession of a personal smartphone from their children until they reach the age of at least sixteen (16) years old, and to prohibit their child from using laptops, iPads, phones, etc. unsupervised.

Families who sign the *Reading & Technology Covenant* will receive 10% off tuition, before any other discounts are applied. Covenant will be reviewed and re-signed annually. Reading logs will be collected each month. If a family demonstrates failure to uphold this Covenant, the Headmaster may determine that the parents are ineligible to submit the covenant for the following school year.

This Covenant is a commitment which is encouraged but not required, and is not related in any way to the terms of enrollment or the agreements therein. This is an “above and beyond” commitment that families may make to more fully integrate into the culture of the school.
