## **STOCK TRANSFER**

Make a bigger impact by donating long-term appreciated securities, including stock, bonds, and mutual funds, directly to charity. Compared with donating cash or selling your appreciated securities and contributing the after-tax proceeds, you can automatically increase your gift and your tax deduction. #### **IRA DISTRIBUTION**

You can make a gift to GMCSF with a distribution from your Individual Retirement Account (IRA) and take advantage of tax savings. The current law extends the charitable IRA rollover provision indefinitely – with no expiration date – allowing individuals to make qualifying gifts every tax year. So, even if you chose to support GMCSF in this way last year, you may do so once again.

Under the Protecting Americans from Tax Hikes Act of 2015, Americans over the age of 70½ may distribute up to \$100,000 in a calendar year from an IRA to GMCSF or other qualified charities free of federal income tax.

#### **GUIDELINES**

Required minimum distributions (RMDs) are the minimum amounts you must withdraw from your retirement accounts each year. You generally must start taking withdrawals from your traditional IRA, SEP IRA, SIMPLE IRA, and retirement plan accounts when you reach age 72 (73 if you reach age 72 after December 31, 2022).

You may distribute any amount up to \$100,000 in a calendar year to charity, as long as it is completed by December 31 of the year in which you intend to make the charitable distribution.

Your IRA administrator must make the distribution directly to the charity.

Before proceeding, you should consult with your tax advisor to discuss your particular situation, including any impact of your state's tax laws. All IRA charitable distributions are restricted from receiving benefits, including tickets.
