As of June 30, 2022, the chorus had 126 members on its singing roster, plus the Artistic Director, Assistant Conductor, and two paid accompanists. To actively pursue its mission, the Chorus produced three concert series during its 2021-2022 season. Throughout the season, a total of four, mainstage performances were executed. Admission was charged for all mainstage concerts, and we welcomed 1,978 attendees. Eleven community-based performances were delivered at no cost to the community and reached a total of 23,650 people
