Requirements for Water Well Projects:

No water well shall be drilled or operated within the City of Star Harbor, Texas unless an application therefor has been made to the B&Z Review Board. The B&Z Review Board will examine the permit request and verify that the proposed well is within property easements. Applications for private water wells shall be processed by the B&Z Review Board who will make a recommendation for approval or disapproval to the Governing Body of Star Harbor. (Ordinance 160). The provisions of this section supersede Ordinance 160.

A private water well shall be used for irrigation purposes only.

A private water well and pump house shall be within the building set-back lines.

Water produced from the irrigation water well shall not be connected to any pipe or plumbing to any residence within the City of Star Harbor, Texas.

In accordance with State of Texas code water wells may not be closer than fifty feet (50') to the dwelling's septic system.

<u>Permit Expiration</u>: If the permitted project is not complete within the specified time, the property owner or contractor shall be required to submit a Building Permit Renewal Application with appropriate fees to the City prior to the current expiration date. Proof of receipt prior to the expiration date is required. All permit renewals will be for a thirty (30) day period. Additional renewals beyond those specifically mentioned are at the discretion of the B&Z Review Board.

<u>Permit Modifications</u>: The property owner or contractor is required to submit a Build Permit Modification request to the B&Z Review Board before making any project changes. Such changes include but are not limited to design changes, material changes, etc.

<u>Inspections</u>: The property owner shall notify the Star Harbor Operations Manager when the well drilling company arrives to place the well. They will also notify the Star Harbor Operations Manager when the private water well is ready for use.
