GOLF COMMITTEE – Committee Chairperson, Paula Holmes, reported that a survey will soon be going out and asked for city council input on golf membership fees, course irrigation/maintenance and duties of the committee.

BUILDING & ZONING – Tanya DeVaney gave a written report of activity of the B&Z Review Board for permits issued in December: additions to dwellings at #11 Land Cove and #15 Sunset Blvd., an accessory building at #53 Westview Drive, a swimming pool at #25 Summit Ridge and a patio with cover at #3 Chapel Hill.
