

**Public Notice Mandatory Language for Monitoring and Reporting Violation
Operational Evaluation Report**

The **CITY OF STAR HARBOR** PWS ID **1070150** has violated the monitoring and reporting requirements set by Texas Commission on Environmental Quality (TCEQ) in Chapter 30, Section 290, Subchapter F. Public water systems in exceedance of an operational evaluation level are required to conduct an evaluation of their source water, treatment and distribution operations and submit a report of their findings to the TCEQ.

We failed to conduct an operational evaluation and/or submit a report to the TCEQ for TTHM/HAA5.

These violation(s) occurred in the monitoring period(s) (HAA5/TTHM) 4Q2025, (HAA5) 3Q2025

We are taking the following actions to address this issue:
We provided our OEL report in a timely manner to TCEQ and returned to compliance as of 03/11/2026.

The TCEQ recommends that the public water system provide a copy of the Public Notice(s) to local and state officials, such as Mayors, City Council Members, County Commissioners, Judges, and/or State Representatives, that are located in or that represent the affected area(s) served by the system.

Public Notice delivery timelines:

The initial public notice shall be issued as soon as possible, but in no case later than 12 months after the violation was identified. Repeat public notice shall be issued every 12 months for as long as the violation persists. All notifications require the attached Certificate of Delivery due 10 days from the posting date of the above notice.
