**A RESOLUTION TO PROCEED TO RENEW A TAX EXCEEDING TEN-MIL  
LIMITATION FOR GENERAL CURRENT EXPENSES OF THE MUNICIPAL  
CORPORATION**

**WHEREAS**, on 11<sup>th</sup> day of April, 2025 the Village Council of the Village of Waynesburg, Stark County Ohio passed Resolution number 2025-4-001 declaring the necessity to renew a tax exceeding the ten mill limitation, in order to generate funds for the purpose of providing for the general current expenses of the municipal corporation, to levy a tax in excess of the ten mill limitation pursuant to Ohio Revised Code Section 5705.19(A) that the county auditor estimates will collect Twenty One Thousand and 00/100 Dollars (\$21,000.00) annually, at a rate not exceeding tow (2) mills for each one dollar of valuation, which amounts to Thirty-Two Dollars (\$32.00) for each One Hundred Thousand dollars(\$100,000.00) of valuation, for a five year period of time, commencing in 2025, first due in calendar year 2026; and

**WHEREAS**, the Stark County Auditor has certified to the Village Council of the Village of Waynesburg, Stark County, Ohio that the dollar amount of revenue that would be generated by the tax levy during the first year of collection is \$21,000.00 based on the current assessed valuation of the Village of Waynesburg, Stark County, Ohio of \$19,730,430.

**NOW THEREFORE BE IT RESOLVED** by the Village Council of the Village of Waynesburg, Stark County, Ohio, at least two thirds of all members concurring, in accordance with Ohio Revised Code Sections 5705.03 and 5705.19 as follows:

**SECTION 1.** That the Village Council shall proceed with submission of a renewal tax levy at the rate of 2 mills for the purposes set forth in Ohio Revised Code Section 5705.19(A) as follows: for the purpose of providing for the general current expenses of the municipal corporation, to levy a tax in excess of the ten mill limitation pursuant to Ohio Revised Code Section 5705.19(A) that the county auditor estimates will collect Twenty One Thousand and 00/100 Dollars (\$21,000.00) annually, at a rate not exceeding two (2) mills for each one dollar of valuation, which amounts to Thirty-Two Dollars (\$32.00) for each One Hundred Thousand dollars(\$100,000.00) of valuation, for a five year period of time, commencing in 2025, first due in calendar year 2026; and

**SECTION 2.** That the Waynesburg Village Council hereby orders that the levy be placed upon the tax lists of the current tax year, in compliance with Ohio Revised Code Section

5705.34, for a five-year period, provided a majority of the electors voting thereon in favor thereof; and

**SECTION 3.** That the Waynesburg Village Council hereby orders that the question of such tax levy shall be submitted to the electors of the Village of Waynesburg at the election to be held therein on November 4, 2025; and

**SECTION 4.** That the Village of Waynesburg fiscal officer is hereby directed to certify, not less than ninety (90) days prior to the November, 4, 2025 election, to the Stark County Board of Elections a certified copy of Resolution 2025-4-001 and a certified copy of this Resolution as well as the Certification of the Stark County Auditor, and notify the Stark County Board of Elections to cause notice of the election on the question of levying the tax to be given as required by law; and

**SECTION 5.** That it is FOUND and DETERMINED that all formal actions of this Council concerning and relating to the adoption of this Ordinance were resolved in an open meeting of this Council and all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
