AN ORDINANCE ADOPTING AND APPROVING THE AMENDED FEE SCHEDULE AND RULES AND REGULATIONS OF THE VILLAGE CEMETERY(S); AND DECLARING AN EMERGENCY.

WHEREAS, The Village of Waynesburg operates one or more Village Cemeteries, within the Village limits of the Village of Waynesburg, and

WHEREAS, The Village of Waynesburg is in need of amended fee schedules and rules and regulations to maintain efficiency in the operation of the Village Cemetery(s), and

WHEREAS, the Village Cemetery Board and the Village Cemetery Sexton have met and compiled a proposed amendment to the cemetery fees and updated standards for the Village Cemetery(s), and

WHEREAS, it is in the best interest of the efficient operation of the Village Cemetery(s) that the recommendations that Exhibit "A" and incorporated herein by reference be adopted.

NOW THEREFORE, BE IT ORDAINED, by the Council of the Village of Waynesburg, Stark County, Ohio as follows:

SECTION 1. The updated fee schedules and rules and regulations of the Village Cemetery(s) attached hereto as Exhibit "A" and incorporated herein by reference be adopted and enforced.

SECTION 2. That the Cemetery Sexton and the Fiscal Officer of the Village of Waynesburg are hereby AUTHORIZED and DIRECTED to enforce and follow said said fee schedules and regulations in accordance with Exhibit "A" attached hereto and and incorporated herein by reference.

SECTION 3. That this Ordinance is hereby DECLARED to be an EMERGENCY MEASURE necessary for the immediate preservation of the public peace, health, safety, and welfare of the citizens of the Village of Waynesburg and for the further reason that the it is necessary for the efficient daily operations of the Village cemetery; and provided it receives the affirmative vote of two-thirds of the members elected to Council, it shall take effect and be if full force immediately upon its passage and approval by the Mayor. Otherwise it shall take effect and be in force from and after the earliest period allowed by law.

SECTION 4. That it is FOUND and DETERMINED that all formal actions of this Council concerning and relating to the adoption of this Ordinance were resolved in an open meeting of this Council and all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
