The undersigned (“Exhibitor”), as a duly authorized representative, enters into an agreement with DDM ASSOCIATES GROUP INC to rent booth space at the above designated 2020 MIAMI DESIGN EXPO. Space will be assigned by the Miami Design expo at its sole discretion and may be changed for the benefit of the exposition. Exhibitor agrees to abide by official Exhibitor Rules & Regulations and has received the booth space terms and conditions. Exhibitor agrees to pay 50% with signed contract. Final balance for booth cost is due June 1st , 2020. If Exhibitor desires to cancel all or part of the exhibit space, they must do so in writing by certified mail to DDM ASSOCIATES GROUP INC. If exhibitor cancels on or before June 1st, 2020, they will be charged a 50% cancellation fee. If exhibitor cancels after June 1st, 2020 100% of the exhibit space is due. If Exhibitor defaults in payment, Exhibitor is liable to DDM ASSOCIATES GROUP for collection costs, including reasonable attorney’s fees. DDM ASSOCIATES GROUP & the board of the Miami Design expo reserves the right to accept or reject exhibitor space applications and to cancel any previously accepted exhibitor space applications or contracts, at any time in its sole discretion, for any reason, or no reason, without liability to Exhibitor or any other party. This contract is not valid until it is fully executed by an authorized representative for Exhibitor and DDM ASSOCIATES GROUP INC.

We understand and agree that this application for Exhibit Space becomes a binding contract when accepted in writing by DDM ASSOCIATES GROUP INC.
