COACH CODE OF CONDUCT:

As a coach I:

Will remember the game is for the youth and not for adults

Will teach skills using coaching techniques that are age appropriate & safety focused.

Will be knowledgeable of the rules of the game and regulations of the league and will teach these to my players.

Will fully comply with all league mercy rule requirements

Will act only in sportsmanlike fashion and will not attempt to embarrass my opponent in any way

Will respond to any league requests or inquiries within 48 hours.

Will actively support association fundraising activities

Will not verbally abuse, threaten, harass, or bait any official, coach, player, cheerleader, spectator or other

Will not tolerate bullying in any manner

Will not engage any parent in any argument but will instead attempt to resolve any situation through unemotional discussions or through the program director

Will **NEVER** come to practice or games under the influence of alcohol or illegal drugs and recognize that violation of rule will lead to immediate dismissal.

Will not hold tryouts, pay for or recruit players to create a "select" team. I understand Jack Frost is a recreational program.

Understand as an assistant coach, I am under the leadership of a head coach and agree to follow the head coach's direction at all times. If I disagree with anything the head coach does, I will address the situation directly or will escalate the issue to the program director.

Unacceptable Behavior:

- Arguments with any official, coach, player, cheerleader, spectator or other
- Physical confrontations of any kind
- Throwing any items on sideline or onto playing field. (clipboards, hats, balls, etc...)
- Using profane language
- Cheating
- Unsportsmanlike conduct
- Bullying

Improper conduct should be reported to program director within 24 hours of incident.
