### **1. Date & Time**

April 6, 2019 from 10 AM to 6 PM

708 W. Seminary St. Vevay, IN 47043

The Expo is being held at the Switzerland County Fair Grounds and the TEC Center. The event will be held rain or shine.

Vendors are invited to set up the Friday from 5-7 pm or Saturday morning on the 6<sup>th</sup> at 8 AM.

### **2. Fees/Refunds**

A \$25.00 refundable deposit is due with the application to ensure vendor booth space. Deposits will be refunded **to vendors who stay the entirety of the event** (6 PM). Full refunds may be issued for cancelations up to the application deadline of February 1, 2019.

### **3. Deadline**

Applications are due by February 22, 2019 at 5:00 pm via U.S. mail, in person, or over the phone via credit card. Applications are not valid without a deposit.

### **4. Booth Space**

Booth space is reserved on a first come first serve basis. Booths are 10x10. For additional space vendors must reserve more than one booth. Larger booths may be placed outside. Placement of exhibitor's booths is at the discretion of Switzerland County Tourism. Exhibitor preference will be given first consideration based on space availability and the date the exhibitor's application was received.

### **5. General Rules**

Absolutely no illegal items, controlled substances, drugs, drug use, paraphernalia, switchblades, guns, ammunition, fireworks, projectiles, inflatables, stink bombs, silly string, disappearing ink, live animals, etc. Selling is only permitted within your booth your booth space. No roaming sales will be allowed. Your booth must be kept neat, clean, and safe for patrons. Any skirting should be securely fastened, and display items must be sturdy and withstand patron browsing. Respect your fellow exhibitors.

\*any vendor with hunting items that were previously *approved* must follow all state laws, regulations and/or licenses & requirements, and you are still agreeing to the terms stated in this application\*

### **6. Electric**

Electric is available but not guaranteed. Please note on your application if electric is necessary for your booth space and we will ***try*** to accommodate.
