## **1. Date & Time**

Friday-Saturday, October 9<sup>th</sup>- 10<sup>th</sup>.

Paul Ogle Riverfront Park at 100 Ferry St. Vevay, IN 47043

Event is Saturday 10 AM - 4 PM. Set up is optional Friday night for the cruise in. Booth must be opened Saturday October 10<sup>th</sup> by 10 AM.

## **2. Fees**

Booth rental is free, but there is a refundable \$20.00 deposit that must be submitted with the application. Vendors who do not show up to the event or leave prior to 4:00 pm forfeit their deposit. Deposits will not be refunded based on weather.

## **3. Deadline**

Applications are due by September 16<sup>th</sup>, 2020 at 5:00 pm via U.S. mail, or in person. Applications are not valid without payment.

## **4. Booth Space**

Booth space is reserved on a first come first serve basis. Electrical outlets are limited and 110 watts ONLY!

## **5. General Rules**

This is a hand-crafted items event. Please **do not bring flea market items or commercially made items.** Absolutely no illegal items, obscene material, controlled substances, drugs, drug use, paraphernalia, alcoholic beverages, switchblades, guns, ammunition, fireworks, projectiles, inflatables, stink bombs, silly string, disappearing ink, live animals, etc. Selling is only permitted within your booth space. No roaming sales will be allowed. Your booth must be kept neat, clean, and safe for patrons. Any skirting should be securely fastened, and display items must be sturdy and withstand patron browsing. No music unless it pertains to the products sold within your booth and it is kept at a low volume. Please respect your fellow exhibitors.

## **6. Booth Placement**

Placement of exhibitor's booths is at the discretion of Switzerland County Tourism. Exhibitor preference will be given first consideration based on space availability and the date the exhibitor's application was received.

## **7. Payment**

Please send a check payable to Switzerland County Tourism with your application. Our office address is located below, or call us to pay over the phone with a credit card. Booth space cannot be held without payment.
