- Our legal documents are being reviewed by Mark Payne of Winzenburg, Leff Purvis and Payne for \$280 per hour for no more than 20 hours. Dave is heading up the project. Dave will request Mark attend our next meeting in February.
- Luminarias
 - We sold 2040 candles in sets of 10.
 - We plan to order 2400 next year.
 - Our profit was \$812.25.
- Holiday Decorations
 - Renni Coleman doesn't plan to put up decorations in 2016. She has found a replacement person to do the job.
 - o Linda is working on an alternate bid for the neighborhood lights.
 - o The HOA has 16 bins that need to be stored. The Town has agreed to store them for us.
- Entrance Feature at Platte Canyon and Fairway.
 - o Jon has talked with Mayor Christy and Michael at the Club. They both like the idea. The next step is to discuss concepts and get a budget.
- Hugh has offered for the Club to take care of our summer 2016 flowers. Hugh and Linda will meet in January to plan for the beds and get a final cost so we can all discuss the plan. Linda will let us know when the meeting is so that anyone can attend if they want.
