- 10 Club Lane has been sent a 3<sup>rd</sup> letter and a letter to collect the fines for the shed.
- 59 Fairway's outside shed was not approved.

## Old Business:.

- We are going to wait to fix the light and power to the sprinkler until we have more cash and after a survey is completed on who owns what property.
- Luminaries.
  - $\circ$  We have the candles and bags ordered. We will sell 2040 luminaries on December 17 from 10-2 as a group (Tim, please bring the heater!). We will meet at 9:30 to get set up.
  - Hugh will provide the sand.
  - o Brian will bring coffee and a tent from the club.
  - We will use a corner of the Club parking lot.
  - We are going to ask people to bring buckets.
  - Linda has signs.
  - O Deb will send Constant Contact fliers 12/3 and 15. She will mail fliers to the 27 homes that we don't have email address for.
  - Linda made a motion that we sell Luminaries for \$15 per 10 pack kit. Judi 2<sup>nd</sup> the motion and it carried.

  - $\circ$  We will send the invoice with the increased fee in March. The pay by date will be 4/15.
  - Deb will reach out to Mark Payne to see what we must do to get the increase approved.
  - We won't change covenants until we have more money in the bank. When we do change our covenants, we need to add a provision for leave clean up.
