2. I understand that after payment of the City of Victor connection charges, the City of Victor will issue a document that I can then take to the Teton County Building Department for the purpose of obtaining a building permit.
3. I understand that, after 1 year from the date of payment, I am not eligible for a refund of the connection fee paid to the City of Victor under any circumstances.
4. I understand that if the City wishes to annex said property, I consent to accept annexation of the property being served into the City of Victor without opposition.
