Please Read & Sign:

By signing below, I am agreeing to volunteer for a free vehicle scan performed by members and volunteers of The Family Shelter of Southern Oklahoma (FSSO). The purpose of the scan is to check for any tracking devices or suspicious gadgets, and I give permission (or confirm that I have permission from the vehicle owner listed on this consent form) for this to be done.

I understand that The Family Shelter of Southern Oklahoma and FSSO volunteers cannot be held responsible if any damage occurs to my vehicle during the scan. I understand that the scan will be done carefully and respectfully; however, accidents or unavoidable damage may occur. I accept this risk and release The Family Shelter of Southern Oklahoma and FSSO volunteers from any liability.

In the event that a tracking device or suspicious gadget is detected, FSSO will provide me with a statement in good faith. I understand that while the intention is not to remove any detected device, there may be certain situations where removal becomes necessary due to safety concerns, accidental discovery, or other unavoidable circumstances.

If I choose to file an incident report and the report is investigated, and the investigation reveals malicious intent, I understand that purposely placing a device to be found or making false or misleading claims is illegal. I accept full responsibility for my actions.

I confirm that I own the vehicle or have permission to have it checked. I understand that if a device is detected and FSSO provides me with a statement letter, including photo documentation to verify the detected device, FSSO will recommend that I file an incident report within my jurisdiction. I understand that both the FSSO statement letter and any filed incident report do not guarantee that further action can be taken at this time, but they may provide a foundation to begin establishing a paper trail.
