- This process is for safety, documentation and awareness only.
- All services provided by Family Shelter of Southern Oklahoma (FSSO) are free and confidential. However, please be aware that all FSSO staff are mandated reporters. If illegal activity or harm to yourself and/or others is discovered during the search, we are required by law to report it to the appropriate authorities.
