

Coaching Service Agreement

Path to Ascended Wellness & Coaching LLC

This Coaching Service Agreement ("Agreement") is entered into by and between Path to Ascended Wellness & Coaching LLC ("Coach") and _____ ("Client"). This Agreement outlines the terms and conditions governing the coaching relationship.

1. Description of Coaching

Coaching is a collaborative, non-therapeutic partnership designed to support personal and/or professional growth, insight, and goal attainment.

Coaching services are educational and supportive in nature and are not psychotherapy, counseling, or medical care. Coaching does not diagnose, treat, or cure mental health conditions or illnesses.

2. Scope of Relationship

Client understands that no therapist-client relationship is formed through this Agreement unless explicitly stated in a separate, written therapy agreement.

Client remains solely responsible for all decisions, actions, and outcomes resulting from the coaching process.

3. Client Responsibilities

Client acknowledges that coaching is a voluntary process and agrees to actively participate.

Client is responsible for their own physical, mental, emotional, and spiritual well-being.

Client agrees to seek appropriate professional or emergency support if distress arises.

4. Services & Scheduling

Coaching services may be delivered in person, virtually, or by phone, as mutually agreed.

Session length, frequency, and duration will be agreed upon in advance.

Client is responsible for initiating and attending scheduled sessions.

5. Fees & Payment

Fees, packages, and payment terms will be agreed upon prior to the start of services.

By engaging in coaching services, Client agrees to the Refund & Cancellation Policy of Path to Ascended Wellness & Coaching LLC, which is incorporated by reference.

6. Cancellation Policy

Sessions must be canceled or rescheduled at least 24 hours in advance.

Missed or late-canceled sessions may be forfeited and are non-refundable, in accordance with the Refund Policy.

7. Confidentiality

Reasonable care will be taken to maintain confidentiality consistent with ethical coaching standards.

Coaching relationships are not legally privileged communications.

Confidentiality may be broken if required by law or if there is risk of harm.

8. Record Retention

Coach may maintain coaching records in electronic or written format for a period consistent with professional and legal standards.

9. Termination

Either party may terminate this Agreement at any time with written notice.

Client is responsible for payment for services rendered through the termination date.

10. Limitation of Liability

Coach makes no guarantees regarding outcomes.

To the fullest extent permitted by law, Coach's liability is limited to the amount paid for services.

11. Governing Law

This Agreement shall be governed by the laws of the state in which Path to Ascended Wellness & Coaching LLC is registered, without regard to conflict of law principles.

12. Entire Agreement

This Agreement, together with the Client Acknowledgment, Informed Consent & Terms of Service, constitutes the entire agreement between the parties.
