Follow-up on communications related to matters addressed during the previous Parent Engagement Committee Meeting: The committee proposed emailing the parent coordinators or PTAs to ask about the platforms that they are using to communicate.  - a. Desines Rodriguez, CEC32 Member: Parent coordinators are calling from blocked phone numbers.
 - b. Selina Lebron, Community Outreach Specialist, NYPCC: Is it possible to be added to your resource list? We serve the Bushwick Community, we're open 7 days a week, open late hours in person and via teletherapy and we have evening hours with NO wait list!
 - c. Laraine DeAngelis, Community Member and Volunteer at the Office of the Council Member Antonio Reynoso: *Has anyone from the DOE reached out to the CEC concerning opening schools in the Fall? Some companies will be donating supplies to schools.* The DOE has not provided this information yet. They will send a survey next week about remote learning.
 - d. Marlene Rossi, Parent: Wondering if an orientation session before the beginning of the school year would be something that can be done. This way parents can meet the teachers, receive the supplies list prior to starting. I think the parent can also help the child adjust to the environment if they know ahead of time what to expect. This question will be brought to the Superintendent, CEC, and DLT.
 - e. Jazzy Rivera, President Presidents' Council: 32K151, 116, 145, 106, 75, and 123 have remote parent engagement for parent learners. Other schools share information through their parent coordinator's Google Classroom page.
