Work meeting opened at 6:00.

In attendance: Lane Blackmore, Miranda Kloos, Kevin Dunkley, Steven DeMille, Steve Finley, Thayne Smith, Alisha Terry-Martin, David Hinton, Nick Turner, Ben Ruesch.

No closed session needed.

Discussion of Board member vacancy left by Lynn Excell resignation: Post opening. Close one week before the board meeting and schedule interviews for Jan 14 meeting.

Discussion of financial services: there has been some overspending in a couple of areas and some months will be tight for the rest of the year, but the account is being watched more carefully now by Red Apple. There may be a couple of months we will be dipping into the line of credit and Lane asks for authorization from the board to sign for that, if needed. Funds would be replaced as soon as possible. Minimum payment will be made on the line of credit for now during this time and hope that we will be able to pay off this loan next year.

Discussion of Building Rental Agreement: only needs a fee schedule. Kevin will create this and possibly be comparable to the Hurricane Community Center so we are not deterring people from wanting to use the facility.

Discussion of policies needed. Miranda will be taking charge of this. Legal encouraging looking at policies that have been used by other schools. Get some input from parents/faculty.

Discussion of refinance of the building. Joel's options don't look very good at this time due to the cost and low probability of acceptance. Red Apple recommends waiting until the purchase option in the contract 2018 or renegotiation of the contract with the landlord. If we can bump up enrollment even a little bit, we should be ok. We need to improve in budget and enrollment in the next two years in order to be eligible for the USDA loan refinance option. Joel's letter read by Kevin.

Discussion of ways to improve arts electives and gain more parent support. Finding more volunteers from the community to boost diversity is important. Improvement of arts electives for the older grades is essential to keeping them interested in staying at the school.

Discussion of a grant writing committee- teachers are interested. Miranda has been working on this.

Discussion of legal fees- continue discussion at next meeting. Legal is willing to go back to an hourly rate instead of the monthly retainer we are currently paying.

Special Band performance by 6-8th grade students.

Regular meeting opened at 7:10


Additional in attendance: Natalie Metzger, Kandace White, Peggy Childs.

Suggestions were offered by them about which doors to lock and possibly changing key locks to electronic fobs- looking at ways to increase security on campus.

We are writing to let you know that Valley Academy Charter School was designated as a Title I Focus School. This designation means that Reading and Math will be Valley Academy's highest priority. We will implement the skills and strategies necessary to accomplish the growth and proficiency required by the USOE. Intervention times are scheduled each week, where teachers assist those needing additional instruction. We have already implemented new curriculum in both Reading and Math and are excited about the progress being made. The program improvement designation provides an opportunity for principals, teachers, and parents to focus on areas of school improvement. Valley Academy and the Utah State Office of Education are working together to improve teaching and learning especially in the areas of reading and mathematics, by providing technical assistance and professional development opportunities to the teachers and administrators within the school. Valley Academy is working to improve its academic program by undergoing a rigorous two-year school improvement effort led by the School Leadership Team and supported by a School Support Team. Parents can effectively assist student achievement improvement in the following ways:

- Communicating frequently with your child's teacher
- Making sure your student attends school regularly
- Helping your student with homework
- Monitoring your student's television time
- Reading aloud to your student
- Volunteering in the classroom
- Participate in school decision-making
