- 1. Welcome and call to order- 7:30
- 2. Minutes from previous meeting accepted as written. Motion by Lane Blackmore, second by Derek Lewis- all members in favor.
- 3. Mission statement read by Tonya Heyder. "The mission of Valley Arts Academy is to provide a superior, character building, academic program enhanced by integrated training in the fine and performing arts with a technologically advanced curriculum."
- 4. Discussion of vision statement- Megan Gatlin made a revision. Discussion to remove the statement about environmental awareness. The following is the updated statement.

Valley Arts Academy provides the opportunity for excellence in academics and the arts. Through the use of a digital curriculum, students will enhance their knowledge of technology. School uniforms give students a sense of safety and belonging, while faculty provides an atmosphere of learning that encourages individuality and lateral thinking. Students can further develop their talents by participating in before and after school programs. Valley Arts Academy is committed to the success of each student and the long-term viability of the school.

5. Steve Goodman brought demographic information to show viability of a student body of 550 instead of 450. Steve presented possible plans for dividing students into grade levels, growing the 7th and 8th grades while still keeping the student body at 550. Other schools in the area have a hard time filling 7th and 8th grades, so it may not be realistic to plan to fill those grades in the first year. The following shows a possible breakdown of grade levels. It will ultimately be driven by enrollment.

Jeff says that all plans for construction will be brought to the board for approval prior to implementation.
