**GENERAL:** Electrical work shall not be started until the application has been approved and an electrical permit issued. No work shall be concealed until it has been inspected and approved by the Electrical Inspector. When ready for an inspection call (956)262-2127. Please note type of inspection, permit number, the date of inspection(s) is requested for and any other important information such as lock box combination, or key location.

**EXPIRATION OF PERMIT:** A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after time of commencing the work. A PERMIT WILL BE CANCELED WHEN NO INSPECTIONS ARE REQUESTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELLED PERMITS CANNOT BE REFUNDED OR REINSTATED. **MAY IT BE UNDERSTOOD THAT THIS IS STRICTLY A GUIDE. IT IS RECOMMENDED THAT THE ELECTRIC INSPECTOR BE CONDUCTED TO ANSWER ANY CODE QUESTIONS. THE PERMIT CLERK IS NOT A CODE OFFICIAL AND IS NOT AUTHORIZED TO ANSWER CODE QUESTIONS.**
