In some rare instances, we may need to transfer your information outside Australia. If we believe that the overseas third party is not subject to, or has not agreed to comply with, privacy obligations equivalent to those which apply to us, we will seek your consent to transfer the information, except where the APP do not require us to do so. If you have given us instructions which necessarily require us to transfer your personal information outside of Australia, you will be deemed to have provided such consent.
