<p>Purposes for which we process personal data</p>	<p>The IWCB will process the personal data for:</p> <ul style="list-style-type: none"> • Administering your application for membership of the IWCB • Administering bookings and attendance at sessions • Dealing with medical needs/specific requirements • Supporting the delivery of cricket sessions • Training and competition entry • Reporting of participation and any incidents and of figures and trends (including equality and inclusion information) • Quality and improvement monitoring • Live streaming matches to IWCB websites/social media channels • Producing match highlights • Promoting and marketing the IWCB • Coaching analysis
<p>Who we may disclose your personal data to</p>	<ul style="list-style-type: none"> • Leagues where you have been nominated for / agree to play for a League • Session coaches / team managers / administrators for delivery of training sessions / matches / festivals • The ECB where you are registered for or express an interest in an ECB programme • The County Cricket Board that supports the local Cricket Club whose programmes you have registered for • Coaches and other volunteers for administering training and other sessions • Live stream footage will be shared with Play-Cricket Live, Sponsors, IWCB website and social media platforms

Legal basis for processing your personal data	<p>The legal basis for the collection and processing of your personal data is:</p> <ul style="list-style-type: none"> • for administration and programme delivery: that it is necessary to fulfil the contract that you are going to enter into or have entered into with us • for dealing with medical needs: that you have given your explicit consent or it is in your vital interests. • in all other cases: that it is necessary for our legitimate interests or those of the ECB which are to build a programme to encourage participation in cricket and this does not prejudice or harm your rights and freedoms. Where we wish to use close-up images or footage of identifiable individuals primarily for promotional or marketing purposes, we will seek the individual's consent where appropriate. Please see IWCB Live Streaming, Photography and Audio-Visual Recording Policy.
Your right to withdraw consent	<p>Where you have given your consent to any processing of personal data, you have the right to withdraw that consent at any time. If you do, it will not affect the lawfulness of any processing for which we had consent prior to your withdrawing it.</p>
Location of your personal data	<p>We will keep your personal data within the European Economic Area. Where matches are live streamed online, footage may be viewed worldwide.</p>
How long we will keep your personal data for	<p>We will not retain your personal data for longer than is reasonable and necessary for the purposes for which it was collected. We shall retain your personal data for such time as you are registered with IWCB as a member.</p> <p>2 years after you cease to be a member of IWCB or play an active part in IWCB, we shall delete your data except that needed to keep historical scorecard and statistical records</p>
Your rights in respect of your personal data	<p>You have the right of access to your personal data and, in some cases, to require us to restrict, erase or rectify it or to object to our processing it, and the right of data portability.</p>
