I understand that payment in full will be due upon the release of the boat, and hereby grant you and/ or your employees, permission to operate/transport the boat herein described on streets, highways, waterways, or elsewhere for the purpose of testing, moving, and inspection. An express mechanic's lien is hereby acknowledged on the above boat or equipment to secure the amount of repairs thereto. Legacy Marine Service Inc., will not be held responsible for the loss or damage to boat or articles left in the boat in case of fire, theft, accident, or any other cause beyond Legacy Marine Service Inc's. control. Old parts removed from the boat will be junked unless otherwise instructed. I authorize any and all supplement payable direct to you. **I have 2 days upon notification of completion to pick up my boat.** IF arrangements with Legacy Marine Service Inc. have not been made, I agree to pay a daily storage rate of \$35 per foot per day for land storage. Be sure any existing balance has been paid in full. We cannot schedule or initiate a work order to begin until all past due Invoices are paid in full. Leave a key; lock combination, or key hiding place. To expedite your service, we must have a set of keys (or combination), Slip# and/ or Mooring# available before scheduled work can begin.
