All estimates are subject to change. Legacy Marine Service Inc. estimates are calculated on a round trip basis and include minimal time to load and unload the vessel. All vessels are required to be ready to transport. If Legacy Marine Service Inc. needs to spend additional time securing objects and/or materials, or removing radar, bimini tops, etc. on the vessel, an additional \$190.00 per hour labor rate will be added. Vessels must be under 13'6 for transport.

All customers are required to have insurance on the vessel to be transported. Proof of insurance must be provided before the scheduled transport.

All customers are to provide Richard's Marine Service Inc. with a credit card for file, payment is due upon delivery of the vessel, the day of delivery. Credit cards are subject to a 2.5% processing fee. Failure to pay upon delivery can result in the Legacy Marine Service Inc. holding the vessel until payment and all late payments will be charged additional storage fees of \$50.00 per day payment is not made.

The undersigned understands that Richard's Marine Service Inc. is not liable or responsible for any physical component of the vessel, before, during, and after transport, that is damaged by the customer or a third party. Legacy Marine Service Inc., is not liable for any loss of articles from the vessel before, during, and after transport. The undersigned releases Richard's Marine Service Inc. from any liability and/or responsibility for any loss or damage that may occur before, during, and/or after transport, that is caused by the customer, third party, or outside force, including but not limited to weather. The undersigned agrees that once Legacy Marine Service Inc. releases the vessel to the customer, the customer has approved of the transport and service and holds harmless Legacy Marine Service Inc. of any damage or loss. The undersigned has agreed that Legacy Marine Service Inc. does not lease or provide any form of stands or blocks for non-storage customers.



Any dispute, controversy or claim arising from this agreement and/ or from services provided within this agreement, that cannot be amicably resolved amongst the parties shall be referred to mediation within the County of Essex, Massachusetts. The parties below agree that the form of alternative dispute resolution listed above will be the sole and exclusive forum for which disputes are settled within the matter of agreement and/or service provided through agreement.

For spring and fall transport customers, the customer agrees this form may be used as an agreement to transport the vessel throughout the same year boating season.
