





## Overview of PPP Portfolio Expansion

### **Potential Oil and Gas Assets**

- ALBERTA, CANADA: Longer term potential of oil production in this large prolific play. Together, with the Indigenous groups, identified areas of interest and developing an entry strategy.
- Evaluating additional conventional oil and gas licenses in Western Ukraine, over three dozen vintage/P&A wells with many ready for rapid re-entry including a drill ready well fully permitted. License areas are even larger than Limnytskyi and located in the "oil" trend of the basin.
- Analyzing and high-grading T-Rex, Texas well portfolio to maximize accelerated payout with minimal investments. Similar projects to heritage PPP wells, but solid due diligence, technical approach and rolling funding from RMD Group. Brings near immediate cashflow and geographic diversity to PPP activities; 60-90 day start line possible.
- Louisiana/Texas anthropogenic CO<sub>2</sub> flood project, NDA signed, data room access granted and analysis has begun.
