He outlined planned improvements to be implemented over the next 10 years, with goals for the first five years and the following five years.

## Legislative Update

OSPE is still monitoring the same 18 bills they were monitoring last quarter. OSPE continues to oppose House Bill 121/Senate Bill 95 (piping materials). This legislation has been around in varying forms for a few years. These bills include language to require public authorities to consider all piping materials that meet the engineering specifications for a state-funded water or waste water project. These bills would take away the PE's autonomy in specifying the type of pipe material. Hearings for these bills occurred in the Ohio House of Representatives in November and the Ohio Senate in October. Another bill with a recent hearing includes House Bill 127 (steel welding). This bill is to establish in the Ohio Building Code requirements pertaining to structural steel welding and bridge welding. OSPE has not yet taken a position regarding this bill.
