- Carey Case: USFS is building a new recreational cabin near Woodpecker Cove and would like the Tribe to name it. She would like to help coordinate a field trip to the site to get more feeling for a name. The name needs to be decided by the end of September/beginning of October. The USFS provides cultural trees and is currently working with Kake about trees. They can also work with PIA to identify trees for cultural use.

     Stephanie at Parks and REc has the understanding the PIA will be in charge of maintenance. If no decision is made, then we will capitalize them.
