J. PIA Enterprises - Nathan Lopez

The Enterprise Board met last month with an update of funds after the one year mark. We had some bigger purchases and some slow months, but rental cars did really well. Highliner had a net of \$131,000 while Tides Inn net \$44,000. The August 2024-August 2025 statement went really well. We are looking at what we can do to increase prices based on winter and summer pricing and interior vs. exterior room prices. We're updating decor in the rooms and around the building slowly.
